This permit shall NOT be granted until the applicant shall have paid the required fee.
- The connection authorized by this permit can be made only by a contractor licensed by the Whitehall Township Board or by the above property owner, providing the "Owner Affidavit" has been accepted by the representative of Whitehall Township.
- A "Water Tap Lead Report" will be provided showing the approximate location of the Tap lead. **THE PROPERTY OWNER OR CONTRACTOR MUST EXPOSE THE TAP LEAD PRIOR TO CONSTRUCTION IN ORDER TO VERIFY THE ACTUAL LOCATION AND DEPTH RELATIVE TO THE BUILDING SANITARY SEWER AT THE STRUCTURE.** Please contact the Whitehall Township DPW Director if you encounter a problem.
- A detailed site/construction plan must be submitted with this application.
